

## Fifth Amended Notice of Joint Public Hearing

NOTE: This notice has been amended a fifth time to reference the Amended Educational Impact Statement (EIS), which was amended to correct attendance data and to include enrollment and attendance data that was not available at the time this EIS was posted. Specifically, the New York City Department of Education (NYCDOE) has corrected the attendance rate for the 2022-2023 school year and has included the attendance rate for the 2023-2024 school year in table 10 (page 18). The NYCDOE has also updated enrollment and utilization for the 2024-2025 school year throughout this EIS and updated the projected costs.

On December 3, 2024, this notice was amended a fourth time to reflect that the Panel for Educational Policy (PEP) meeting at which this proposal is expected to be voted on will take place on March 12, 2025 at 6 P.M. Details about attending that PEP meeting scheduled for March 12, 2025 are contained in the final portion of this Fifth Amended Notice.

- On November 14, 2024, this notice was amended a third time to update the location of the PEP meeting scheduled for December 4, 2024 at 6 P.M.
- On October 29, 2024, this notice was amended a second time to include the location of the PEP meeting scheduled for December 4, 2024.
- On October 28, 2024, this notice was amended a first time to update the date of the PEP meeting at which these proposals were expected to be voted on to take place on December 4, 2024.

No changes have otherwise been made to the original EIS for this proposal posted on September 13, 2024.

The Proposed Grade Truncation of P.S. 180 Hugo Newman (03M180) from a K-8 School to a K-5 School in Building M180 in the 2025-2026 School Year

## **AND**

The Proposed Re-siting of P.S. M226 (75M226) from Building M076 to Building M180 and Colocation with P.S. 180 Hugo Newman in the 2025-2026 School Year

A Joint Public Hearing was held to provide the public with an opportunity to learn more about the above-referenced proposals and to present comments or concerns on these proposals. The date, time, and location of the hearing were as follows:

This Joint Public Hearing was an opportunity to learn more about potential changes to building M180 and share feedback.

The NYCDOE is proposing to truncate grades 6-8 of P.S. 180 Hugo Newman (03M180), referred to as P.S. 180, in building M180 in the 2025-2026 school year. If this proposal is approved, the school will no longer enroll students in grades 6-8 after the 2024-2025 school year. P.S. 180 is a district school serving students in grades K-8 as well as 3-K and pre-Kindergarten (pre-K) programs in M180. M180 is located at 370 West 120<sup>th</sup> Street, New York, NY, 10027, in Community School District 3, referred to as District



3. M180 also houses the community-based organization (CBO) Road to Success and the school-based health center run by Ryan Health.

A grade truncation means that the school will serve fewer grades than it currently offers.

If this proposal is approved, P.S. 180 will no longer enroll students in grade 6-8 after the 2024-2025 school year. Beginning in the 2025-2026 school year, P.S. 180 will only serve students in grades K-5 as well as its 3-K and pre-K programs.

In a separate Amended EIS, the NYCDOE is concurrently proposing to re-site one site of an existing District 75 school, P.S. M226 (75M226), referred to as P226M@M076, from building M076 to M180 and co-locate it with P.S. 180 in the 2025-2026 school year. P226M@M076 currently serves students in grades K-5 in M076, located at 220 West 121 Street, New York, NY 10027 in District 3. P226M@M076 serves students in special classes, and also serves an inclusive education program that is affiliated with P.S. 76 in M076. This means that P226M@M076 students take some classes with general education students at P.S. 76 and receive special education programs and services as recommended on their Individualized Education Programs from P226M@M076. P226M@M076 is currently co-located with P.S. 76, A. Philip Randolph (03M076), referred to as P.S. 76, a district school currently serving students in grades K-8 as well as 3-K and pre-K programs. M076 also houses the CBO Harlem Children's Zone.

A re-siting means that part or all of a school will be moved to a different building than the building in which the school or part of the school was previously located. A co-location means that two or more school organizations are located in the same building and may share common spaces, such as auditoriums, gymnasiums, libraries, and cafeterias.

If this concurrent proposal is approved, P226M@M076 will be re-sited and co-located with P.S. 180 in M180, and the District 75 inclusion program will be partnered with P.S. 180 instead of P.S. 76 A. Philip Randolph (03M076), referred to as P.S. 76, beginning in the 2025-2026 school year. If this concurrent proposal is approved, P226M@M076 will be referred to as P226M@M180.

In another separate Amended EIS, the NYCDOE is proposing to concurrently truncate the grades of P.S. 76 from K-8 to 6-8, re-site current 6-8 school Mott Hall II (03M862) from building M165 to M076, merge P.S. 76's grades 6-8 with Mott Hall II, and expand the grades of Mott Hall II from 6-8 to 6-12 beginning in the 2025-2026 school year.

The concurrent proposals described above are all contingent upon each other in order to ensure strategic alignment. All three proposals will be voted on separately by the PEP.

The PEP is expected to vote on these proposals on Wednesday, March 12, 2025, at Bayard Rustin Educational
